ELECTION to the CO-OP POWER REGIONAL NETWORK BOARD

BACKGROUND INFORMATION: Co-op Power is a consumer-owned cooperative with 820 members now and several hundred more joining in the next six months as they sign up for community solar subscriptions in Easthampton and NYC. Co-op Power is a network of community energy cooperatives in New England and New York. Each Community Energy Co-op elects a representative to the Regional Network Board. There are 7 Board Seats reserved for the CEC's and 3-5 additional at-large seats for all of the Members to elect together to the board. Candidates who receive at least 50% of the votes cast are elected to the open board seats and serve a 3-year term. ½ of the board seats are up for election each year.

The Board has one seat for each Community Energy Cooperative in our network elected by the members in those Cooperatives and 3-5 at large seats elected by all Co-op Power Members. There are a total of 9 Board Seats on the Northeast Biodiesel Board: Co-op Power has <u>2 seats elected by Co-op Power members</u> and 3 appointed by the Co-op Power board.

Members vote for up to two candidates:




Dan Post to be elected by the Co-op Power members as their representative on the Northeast Biodiesel Company, LLC Board
